**Delegation of Powers by the Public Service Commission in terms of Article 57(1)
of the Constitution**

1. BY virtue of the powers vested in terms of paragraph (1) of Article 57(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka, Part I of the Schedule published in the *Gazette Extraordinary* No.1941/41 dated 20.11.2015 as amended by *Gazette Extraordinary* Nos. 1955/22 dated 25.02.2016 and 2016/37 dated 26.04.2017 through which powers were delegated by the Public Service Commission is amended with effect from 12.06.2018 by inclusion of the new provisions under No.20 in part I of the Schedule aforesaid.
