Observations and recommendations for all functions other than those mentioned below in Para 03 (i) (viii) should be personally submitted by the respective Secretary or the Head of the Institution mentioned in the Column 'B' of the above Table in respect of the Services / Category of Officers listed in Column (A).
- 03. A Secretary to the Ministry listed in Column "B" of the above Table may nominate any Additional Secretary by name of his / her Ministry to submit to the Public Service Commission, on behalf of him / her, any recommendation, observation and any other information required by the Commission to determine any matter listed below with respect to a Service / Category of officers listed in Column "A" of which he / she is the designated administrative authority and the approval of the Public Service Commission should be obtained for the same.
 - (i) Confirmation in appointment in accordance with the provisions of the relevant Service Minute/ Scheme of Recruitment
 - (ii) Promotions in Grade II and I of SL I Salary categories in terms of the relevant Service Minute/ Scheme of Recruitment
 - (iii) Release from Public Service to any other post or to any post outside the Public Service or release to a post in Provincial Public Service

- (iv) Appointment for acting duties/attending to duties
- (v) Concession for efficiency bar examinations
- (vi) Retirement under Public Administration Circular 30/88
- (vii) Making recommendations in respect of appeals against a decision made by the authority with delegated power
- (viii) Resignation from service
- 04. Furthermore, the Public Service Commission has observed significant delays in designating administrative functions, as mentioned above, to a successor appointed to the post of Additional Secretary upon the end of the tenure of the preceding Additional Secretary.
- 05. Accordingly, in order to avoid unnecessary delays in the human resource management functions of the Public Service, you are kindly informed to include your recommendations, in case you intend to assign administrative functions related to the powers exercised by the Public Service Commission to the post of Additional Secretary, whenever you make a recommendation to the Public Service Commission for the appointment of a new Additional Secretary to your Ministry, henceforth.
