Delegation of Powers by the Public Service Commission in terms of Article 57(1) of the Constitution

01. BY virtue of the powers vested in terms of paragraph (I) of Article 57(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka, the delegation of powers referred to under Nos. 15 and 16 of Part I of the Schedule published in *Gazette Extraordinary* No. 1941/41 dated 20.11.2015 is amended by *Gazette Extraordinary* No. 1955/22 dated 25.02.2016 by which the public service delegated power is amended as set out below and the Part I of such Schedule is hereby amended with effect from the date 26.04.2017, by inserting the provisions hereunder set out in No. 14(C) and 19.
