THE CONSTITUTION OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA

Delegation of powers by the Public Service Commission in terms of Article 57 as specified by the Cabinet of Ministers

BY virtue of the powers vested in the Public Service Commission in terms of Article 57 of the Constitution of the Democratic Socialist Republic of Sri Lanka, the said Public Service Commission as specified by the Cabinet of Ministers at the Cabinet meeting held on 16th November 2011, does hereby -

1. Delegate to the Public Officers specified in Column II of the Schedule hereto, its power of appointment, promotion, transfer, disciplinary control and dismissal as are specified in Column III of the schedule hereto, in respect of the categories of Public Officers as are specified in Column I of the Schedule hereto.

Provided that in the event of any question arising in respect of any delegation or as to the implementation of delegation made by Public Service Commission so made, the decision of the Public Service Commission shall be final and conclusive.

Provided further that, if the Public Officers specified in Column II is the complainant or a witness or a potential witness at any disciplinary inquiry against a public officer specified in Column I, the Public Service Commission shall notwithstanding any delegation which may have been made by it, continue to exercise its power of appointment, promotion, transfer, disciplinary control and dismissal as are specified in Column III of the Schedule hereto as if no delegation in respect thereof had been made.

- 2. Specify that all decisions made by a public officer in the exercise of the powers herein delegated to him by the Commission shall be exercised subject to the provisions of Article 58 of the Constitution.
- 3. Specify that in the exercise of the powers herein delegated, the public officers to whom such powers are delegated shall at all times comply with the Procedural Rules, in respect of appointment, promotion and transfer of public officers, made by the Public Service Commission in terms of Article 61B and 58(1) of the Constitution and also with such conditions and any Rules, Regulations and other Procedures which the said Commission may from time to time determine:

Provided that till such time as the Commission promulgates any Rules, Regulations or Procedure in respect of matters not provided in the said Procedural Rules, all other Rules, Regulations and Procedures relating to public service as were in force on the date of the coming in to operation of the 18th Amendment to the Constitution, shall *mutatis mutandis* continue to be in force and apply to the Public Service as if they have been made or provided by the Public Service Commission.

4. Exercise directly in respect of the public officers not specifically mentioned in the schedule hereto, the powers vested in it in terms of Article 55 of the Constitution:

Specify that this delegation will take effect from 1st January 2012 and with effect from same date, the Delegation of Powers published in *Gazette Extraordinary* No. 1295/26 of 2nd of July 2003 by Public Service Commission and the Delegation of Powers published in *Gazette Extraordinary* No. 1449/12 dated 13th of June 2006 by National Police Commission, shall be rescinded, without prejudice to any action taken or purported to be taken under the Delegation of Powers published in the aforesaid *Gazette*.
